# Foster care agencies in San Luis Obispo County launch a state-of-the-art interactive web portal to increase the number of foster families in their communities

Matching potential foster families to youth in need is made easier by a new website that answers questions for prospective foster parents to reduce concerns that make families hesitant to commit.

In the past <x months>, there have been over 150 days where youth were placed in Motels requiring 24/7 trained staff supervision due to lack of foster families. Today, FCNI has launched a new web portal that provides potential foster parents with a streamlined exploration experience of how they might fit in to a foster child's life. The portal takes in their personalized information and routes them to the right starting point. The portal also provides testimonials from existing foster families with real-world experience, clears out any misunderstandings the potential parents might have and helps them to quickly understand the realities of foster parenting while connecting them with the resources they need to move forward.

There is a critical need in San Luis Obispo County to provide more foster families to children and youth in our communities. Prospective foster families have questions, concerns and uncertainties of becoming foster parents. Whether the future household is an older, retired family with adult children or a single parent with young children, all people considering foster care need help deciding if this is a good decision for them.

By launching a new interactive website, interested individuals and families can determine which options are available to them by answering key questions about their personalities and lifestyles. This personalized experience helps prospective foster families conceptualize what it might be like to be a foster family.

"We understand that people considering foster care are apprehensive. This new web portal will help address their concerns so they can feel more confident to move forward towards becoming foster parents", said Jim Roberts, CEO of Family Care Network, Inc.

When visitors enter the interactive web portal, they will share their hobbies, location, time commitments, housing information, and other questions directing them to areas providing the best fit based on their availability and qualifications. Information that describes how foster care works and support agencies provided to foster families is described in detail. Guidelines to connect with other foster parents and agency representatives will be provided, as well as videos visualizing real experiences.

"Before this web portal was launched, I struggled to commit to being a foster parent even though I knew I wanted to help children in need. I just didn't have enough information to ease my uncertainty. Now that I'm able to find information and support specific to me, I can visualize what foster family life is like. With this certainty, I'm moving ahead and will soon have a foster child to care for", said Martha, a new foster parent.

Citizens in San Luis Obispo County can now use an interactive web portal to get pertinent information and support options to help with the decision-making process to become a foster family. The portal is a critical tool for increasing the number of foster families in our community, building successful fostering environments, and providing foster children with the stability that they need to re-establish themselves and live healthier, more productive lives.
